'Where am I' Park Discovery contest rules

1. General contest rules

These rules are the standard terms and conditions applicable to the Park Discovery contest administered by the Township of Severn. The contest is open only to residents and property owners in Severn and is being conducted according to the law of Ontario and applicable Canadian law. No purchase is necessary. Void in whole or in part where prohibited by law. Entry in the contests constitutes full and unconditional acceptance of these contest rules (the "contest rules").

To be eligible to enter the contest, an individual must:

- be aged 18 or older
- not be employed by the Township of Severn
- complete the entry form at severn.ca/parkcontest to the satisfaction of the Township of Severn by Sunday, June 30, 2024, at 11:55 p.m. Eastern Standard Time (EST)

Township of Severn shall have the right at any time to require proof of identity and/or eligibility to participate in the contest. Failure to provide such proof may result in disqualification. All personal and other information requested by and supplied to the Township of Severn for the purpose of the contest must be truthful, complete, accurate, and in no way misleading. Township of Severn reserves the right, in its sole discretion, to disqualify any entrant should such an entrant at any stage supply untruthful, incomplete, inaccurate, or misleading personal details and/or information.

2. Contest period

The contest will run from June 6 2024, 12:00 p.m. EST, to Sunday, June 30, 2024, at 11:55 p.m. EST.

3. How to enter

There is no purchase necessary to enter the contest. To enter the contest, an individual must scan the QR code found in the park that is the subject of the clue and complete the online form at:

severn.ca/parkcontest. No group or team contest entries.

Three randomly selected winners will each receive a prize valued at a maximum of \$100 (with tax included). The winner will be contacted by the Township of Severn by either phone or email. Prizes must be accepted as awarded and cannot be transferred, assigned, substituted, or redeemed for cash, except at the sole discretion of the Township of Severn. The Township of Severn reserves the right, in its sole discretion, to substitute a prize of equal or greater value if a prize (or any portion thereof) cannot be awarded for any reason. Township of Severn shall not assume any liability for lost, damaged, or misdirected prizes.

4. Selection of the winners

Following the end of the applicable contest period, the Township of Severn will select three entrants by a random draw from all eligible contest participants. The odds of being selected as a potential winner are dependent upon the number of eligible contest participants.

Although multiple entries are permitted, once randomly selected for one prize, the individual is removed from the selection for the additional two prizes.

The selected entrants shall be advised they have been selected and will be required to correctly answer, without assistance of any kind, whether mechanical or otherwise, a time-limited mathematical skill-testing question to be administered during a pre-arranged telephone

call or by e-mail, to comply with these contest rules and may be required to sign and return the Release (described below).

If the selected entrant does not respond within five (5) business days of notification, they will be disqualified and will not receive a prize and another entrant may be selected (as determined by the Township of Severn) in its sole discretion) until an entrant satisfies the terms set out herein. Township of Severn is not responsible for the failure for any reason whatsoever of a selected entrant to receive notification or for the Township of Severn to receive a selected entrant's response.

5. Indemnification by entrant

By entering this contest, entrant(s) agree to release and hold the Township of Severn harmless from any and all liability for any injuries, loss or damage of any kind to the entrant(s) or any other person, including personal injury, death, or property damage, resulting in whole or in part, directly or indirectly, from acceptance, possession, use or misuse of any prize, participation in the contest, any breach of the contest rules, or in any prize-related activity. Each entrant agrees to fully indemnify the Township of Severn from any and all claims by third parties relating to the contest, without limitation.

Winners (and if applicable, any guest of the winner) may be required to execute a legal agreement and release ("Release") that confirms the individual's:

- (i) eligibility for the contest and compliance with these contest rules
- (ii) acceptance of the prize as offered
- (iii) release of the Township of Severn from any and all liability for any loss, harm, damages, cost, or expense arising out of participation in the contest, participation in any contest-related activity, or the acceptance, use, or misuse of any prize, including but not limited to costs, injuries, losses related to personal injuries, death, damage to, loss or destruction of property, rights of publicity or privacy, defamation, or portrayal in a false light, or from any and all claims of third parties arising therefrom.

The executed Release(s) must be returned within two (2) business days of the date indicated on the accompanying letter of notification or verification as a winner, or the selected individual(s) will be disqualified and any rights the individual may have to the prize will be forfeited.

6. Limitation of liability

Township of Severn assumes no responsibility or liability for lost, late, unintelligible/illegible, falsified, damaged, misdirected or incomplete entries, notifications, responses, replies or any Release, or for any computer, online, software, telephone, hardware or technical malfunctions that may occur, including but not limited to malfunctions that may affect the transmission or non-transmission of an entry. The Township of Severn is not responsible for any incorrect or inaccurate information, whether caused by website users or by any of the equipment or programming associated with or utilized in the Contest or by any technical or human error which may occur in the administration of the Contest

7. Privacy/use of personal information

By entering the contest, each entrant grants to the Township of Severn (including Recreation, Parks, and Facilities staff) the right to use their/his/her Personal Information for the purpose of administering the contest. This includes but is not limited to contacting the winners and coordinating the transfer of the contest prize. Severn will use each entrant's personal information only for identified purposes and protect each entrant's Personal Information in a manner that is consistent with the Township of Severn's Privacy Policies. 8. Termination

Township of Severn reserves the right, in their sole discretion, to terminate the contest, in whole or in part, and/or modify, amend, or suspend the contest, and/or the contest rules in any way, at any time, for any reason without prior notice.

9. These are the official contest rules

The contest is subject to applicable federal, provincial, and municipal laws and regulations. The contest rules are subject to change without notice to comply with any applicable federal, provincial, and municipal laws or the policy of any other entity having jurisdiction over the Township of Severn and/or the contests. All issues and questions concerning the construction, validity, interpretation, and enforceability of the contest rules or the rights and obligations as between the entrant and the Township of Severn in connection with the contests shall be governed by and construed per the laws of the province of Ontario including procedural provisions without giving effect to any choice of law or conflict of law rules or provisions that would cause the application of any other jurisdiction's laws.
